(i) Immediately following the execution of the Securities Purchase Agreement with the Issuer on May 23, 2023 (the **'SPA**'') (as disclosed in the Form 8-K filed by the Issuer with the Securities and Exchange Commission on May 24, 2023), each of the Reporting Persons may have been deemed to have beneficial ownership of 175,055 shares of Common Stock to be issued to Intracoastal at the closing of the transaction contemplated by the SPA, and all such shares of Common Stock in the aggregate represent beneficial ownership of approximately 6.8% of the Common Stock, based on (1) 2,388,157 shares of Common Stock outstanding as of May 23,

2023, as reported by the Issuer, plus (2) 175,055 shares of Common Stock to be issued to Intracoastal at the closing of the transaction contemplated by the SPA.
